Meet at the Beaverton Town Square Fred Meyer southeast side parking lot, at 11745 SW Beaverton Hillsdale Hwy, Beaverton, OR 97005 at 9:30 AM.

Drivers meeting is at 9:45 AM, with departure at 10:00 AM sharp.

Our destination is the Camp 18 Restaurant, 42362 Highway 26, Elsie, OR 97138, phone 503-755-1818, with arrival about 12:30 PM.

The tour is 80 miles in length and should take about 2 hours to drive.

There will be one 20-minute planned rest stop during the tour. Watch for bicyclists, pedestrians, tourists, wine-tasters and plenty of tree debris and loose gravel on the roads. Enjoy the roads and scenery!

Restroom facilities should be open at Bald Peak State Park along our route at about 24 miles and 45 minutes from the Beaverton starting point.

PLEASE have a full fuel tank and empty bladders!

Some Directions for the Tour:

- You will NOT drive on gravel roads; DO NOT enter any gravel roads.
- You will NOT enter onto or drive on any residential driveways.
- You will NOT enter onto any “Dead End” posted roads.
- When directed “Onto” you will remain on that road (by name) until you are directed off.
- When turning: “Bear” is substantially less than 90 degrees, “Acute” is substantially greater than 90 degrees.

Lunch is no-host. They are expecting us at 12:30 PM, and hopefully we will be able to sit together at the large center table. Please be patient, it might take some time to be served.

To return to the Portland metro area, simply turn RIGHT onto US Hwy 26.

ZERO TRIP ODOMETER as you turn RIGHT (westbound) at signal onto SW Farmington Rd (OR Hwy 10) upon exiting parking lot access street.

0.00 – RIGHT at signal onto SW Farmington Rd (OR Hwy 10) westbound

0.20 & 0.90 & 1.45 – STRAIGHT at signal to remain on SW Farmington Rd

2.80 – Move to LEFT lane (attention - right lane is a forced right turn)

2.95 & 3.65 – STRAIGHT at signal to remain on SW Farmington Rd

8.35 – LEFT at 4-way stop (red blinker) onto SW River Rd

11.30 – RIGHT at traffic circle, then RIGHT at FIRST EXIT onto SW Scholls Ferry Rd (OR Hwy 210)

13.10 – Continue STRAIGHT onto SW Hillsboro Hwy (OR Hwy 219)

17.90 – RIGHT onto NE Mountain Top Rd (**sign hard to see**, was covered in moss recently – if you pass “Welcome to Yamhill County” sign you’ve gone too far – **DO NOT TURN AROUND**, simply continue on Hwy 219 1.5 miles, then turn RIGHT at SW Bald Peak Rd and continue to Bald Peak State Park.

20.95 – STRAIGHT as possible at stop sign onto SW Bald Peak Rd, watch for traffic from left.

23.95 – LEFT into Bald Peak State Park

Enter into the park, following the road to the right to its end, turn around and return back towards the park entrance/exit.

24.20 – Park your car – we have a 20-minute stop here. The restrooms are to the right.

When ready to depart, proceed to the park entrance/exit, there is NO stop sign.

ZERO TRIP ODOMETER as you turn LEFT onto SW Bald Peak Rd.

0.00 – LEFT onto SW Bald Peak Rd, traffic does not stop

1.85 – Acute LEFT at stop sign onto SW Laurelwood Rd

5.10 – RIGHT at stop sign onto SW Spring Hill Rd, traffic does not stop

5.85 – Bear LEFT to remain on SW Spring Hill Rd (SW LaSalle Rd)

6.30 – Bear RIGHT to remain on SW Spring Hill Rd (SW Copenhaver Rd)

7.45 – STRAIGHT to remain on SW Spring Hill Rd (SW Gaston Rd)

10.30 – Bear RIGHT at stop sign onto Tualatin Valley Hwy (OR Hwy 47), traffic does not stop from either direction

11.98 – LEFT from LONG left turn lane onto B St

12.12 – LEFT onto SW Stringtown Rd

13.95 – STRAIGHT at stop sign to remain on SW Stringtown Rd (SW Ritchey Rd)

16.65 – Bear LEFT at Y, then LEFT at stop sign onto NW Gales Creek Rd (OR Hwy 8), traffic does not stop from either direction

22.95 – LEFT at stop sign onto NW Wilson River Hwy (OR Hwy 6), traffic does not stop from either direction

26.30 – RIGHT onto NW Timber Rd

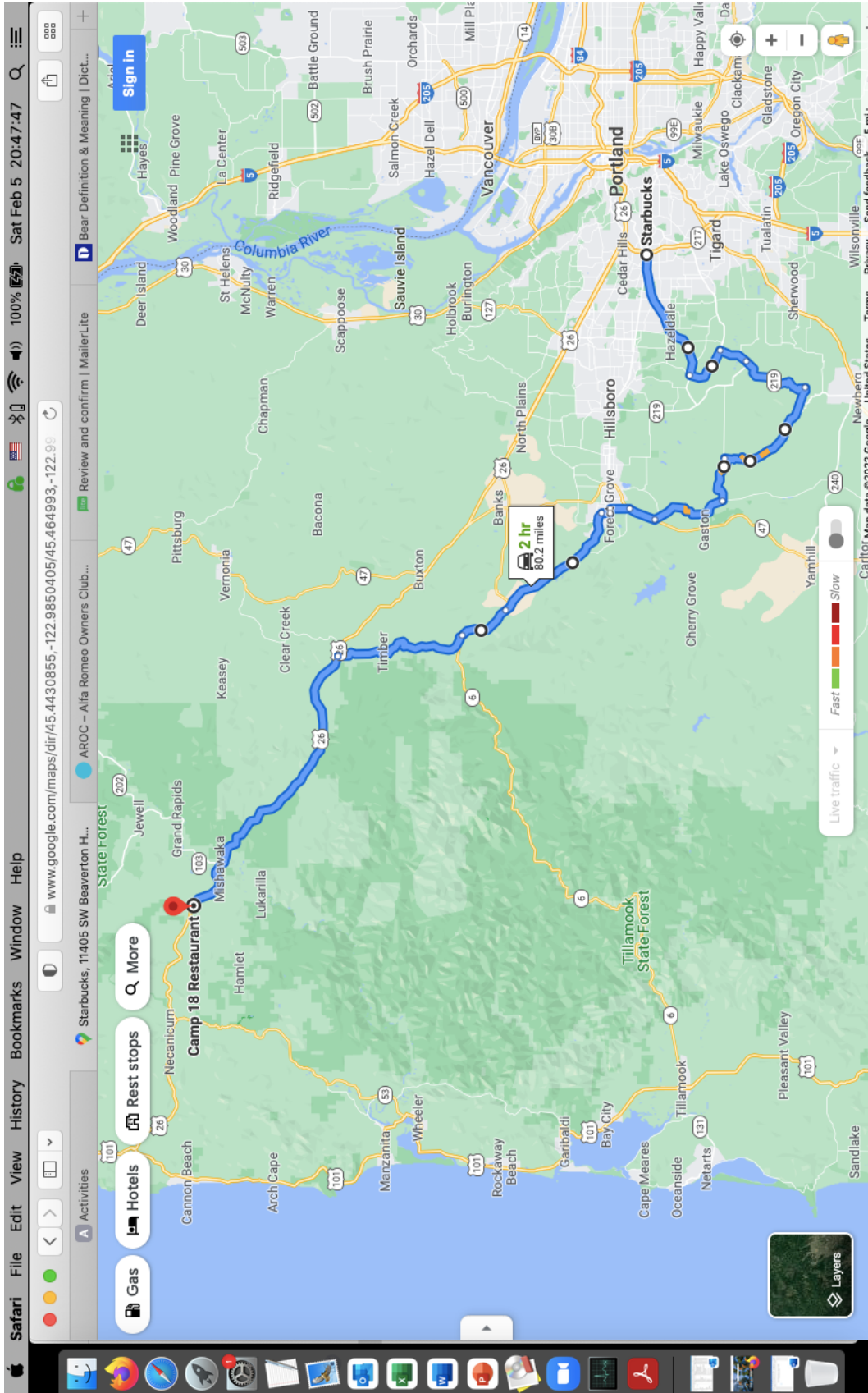
35.90 – LEFT at stop sign onto NW Sunset Hwy (US Hwy 26, westbound), traffic does not stop from either direction

55.85 – **CAUTION: LEFT from SHORT LEFT TURN LANE on US Hwy 26** into Camp 18 Restaurant parking lot.

Immediately turn RIGHT and proceed parallel to highway toward farther parking lot if parking in front is full.
